

Batting Cage/ Facility Rules & Regulations

- 1. FIS is not responsible for any injuries incurred while using this facility.
- 2. All participants must have a Membership Waiver form on file with FIS. Participants under age 18 must also have form signed by legal parent or guardian. It is the responsibility of the coach/manager to assure all participants have a waiver on file.
- 3. All individuals or teams must sign daily log sheet every visit. Daily log sheet is at the front desk sign-in area.
- 4. All batters must wear helmets at all times while in cages. Adult coaches within the cages must remain behind protective 'L' screens during live pitching, or use of pitching machines. Catchers in the cage will wear full protective gear.
- 5. Only one batter is allowed in a cage at any time.
- 6. No practice swings or swinging of bats allowed outside the cages at any time. This includes hitting
- 7. 'soft toss' outside the nets.
- 8. Spectators or individuals "on-deck" must remain seated at bleacher seating. All individuals must remain 3'-0" back from suspended netting at all times, behind painted warning lines.
- 9. Absolutely no running or horseplay within facility.
- 10. No hitting balls against facility walls.
- 11. No playing catch anywhere outside cage, whether inside the building or outside.
- 12. ONLY coaches or authorized adults are allowed to operate pitching machines. No balls will be pitched or loaded into pitching machines while balls are retrieved. Pitching machines will be disabled (cut the power) while balls are retrieved.
- 13. Protective netting shall never be pulled back in any way.
- 14. Please assure that all baseballs are picked up and placed in their proper containers.
- 15. Leave the cage clean the next scheduled team.
- 16. Practicing teams have the right to "closed" batting cage sessions and may politely request spectators not associated with their respective teams to leave the cage area.
- 17. The use of any cage by teams or individuals must be scheduled by FIS, prior to use.
- 18. Absolutely no unauthorized persons shall enter the cage area.
- 19. Liquids are limited to plastic bottles only with cap lids. No open mouth containers are allowed in facility. Clean up all spills immediately.
- 20. Sunflower seeds are prohibited in the facility.
- 21. Coaches will assure that all garbage or other waste is picked up and properly disposed of prior to vacating facility. Leave the area cleaner than you found it!
- 22. Immediately notify the FIS manager on duty regarding any equipment, safety hazards, or unsafe conditions that may exist.

ANY VIOLATION OF THESE RULES WILL RESULT IN THE PARTICIPANT'S IMMEDIATE EJECTION FROM THE FACILITY AND MAY ALSO RESULT IN THE LONG-TERM LOSS OF FACILITITES PRIVILEGES.
